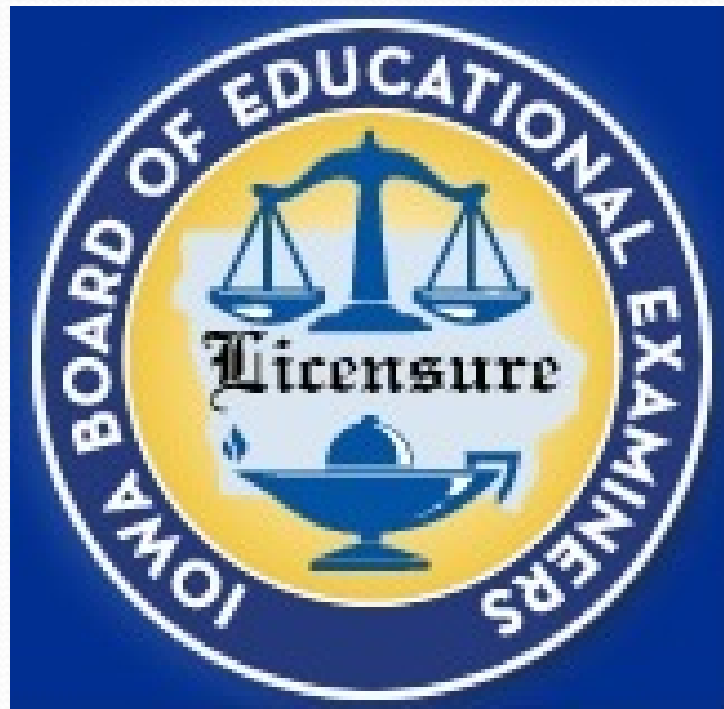

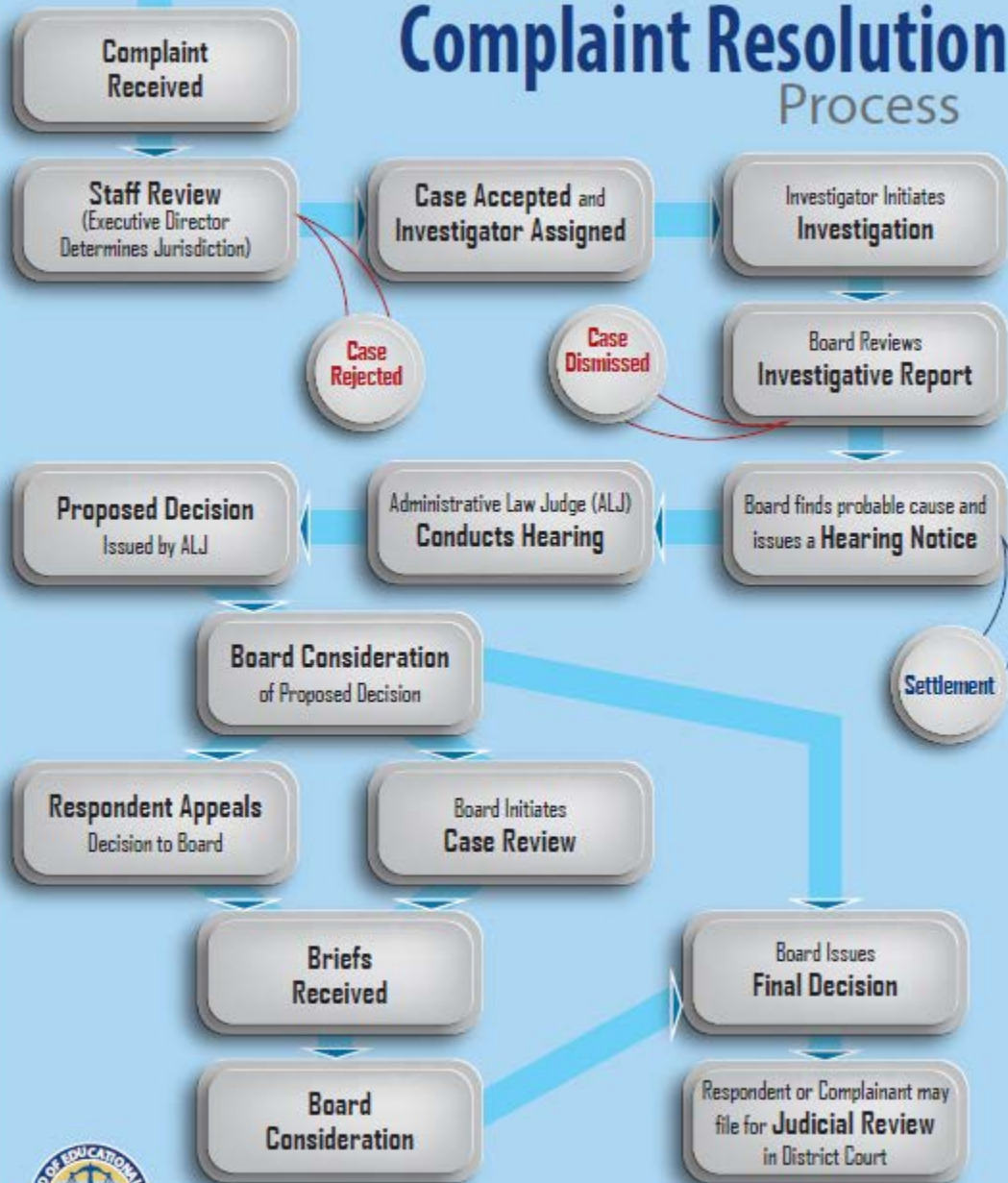
What you should know about the Board of Educational Examiners

- Our office is on the 3rd floor of the Grimes building.
(8:00-4:30 Mon. – Fri.)
- Our staff has been reduced from 15 to 12.
 - Director, 6 consultants, attorney, investigator, tech specialist, 2 clerical.
- We are a fee based agency.
 - 25% of fees are transferred to the General Fund.
- We process approximately 30,000 applications per year.
- All applications are available online.*
- Processing time is 4-8 weeks but can often be within 1-2.
 - New grads are a priority.
- Our goal is to answer all phone calls and emails within a 24-hour period (1 business day).

What you should know about the Board of Educational Examiners continued

- We receive, investigate, and hold hearings for ethics complaints.
 - ~200/yr
- A twelve-member board oversees professional practices as outlined in Iowa Code Chapter 272 and Iowa Administrative Code 282.
 - 2 public, 1 DE, 9 licensed practitioners (4 administrators).
- Our board is represented by the Attorney General's office.
- Hearings are conducted by an Administrative Law Judge.
- Information reported to the board is confidential. Only a final order and notice of hearing are a public record.

BoEE Complaint Resolution Process



Iowa Code 272 requires complaints to be resolved within 180 days
 "...unless good cause can be shown for an extension of this limitation."

BoEE Code of Professional Conduct and Ethics

- Google yourself
- You do not shed your BoEE licensure simply because you are not at work.

BoEE Code of Professional Conduct and Ethics

- Mandatory Reporting *IF* disciplined by the district (written reprimands, written warnings, job separation agreements, resignations, nonrenewals, or terminations that resulted from employee misconduct covered by the mandatory reporting areas)
 - (a) Soliciting, encouraging, or consummating a romantic or otherwise inappropriate relationship with a student.
 - (b) Falsifying student grades, test scores, or other official information or material.
 - (c) Converting public property or funds to the personal use of the school employee
 - (d) *Being on school premises or at a school-sponsored activity involving students while under the influence of, possessing, using, or consuming illegal drugs, unauthorized drugs, or alcohol.* (HF 217)*
